INSTRUMENT OF RATIFICATION OF THE PROTOCOL 6-RAILWAYS BORDER AND INTERCHANGE STATIONS

WHEREAS, the Royal Government of Cambodia has signed the Protocol 6-Railways Border and Interchange Stations on 16 December 2011, in Phnom Penh, the Kingdom of Cambodia;

WHEREAS, the article 8 paragraph 3 of the Protocol provides that this Protocol is subject to ratification or acceptance by the Contracting Parties. The Instrument of Ratification or Acceptance shall be deposited with the Secretary-General of ASEAN who shall promptly inform each Contracting Party of such deposit;

AND WHEREAS, His Majesty the King of Cambodia ratified the abovementioned Protocol on 09 June 2013;
