

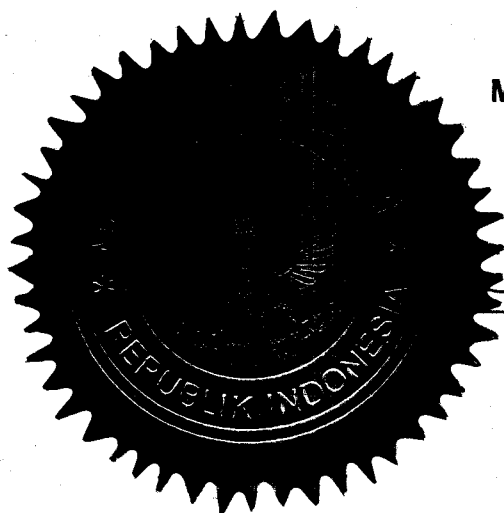



WHEREAS, the Government of the Republic of Indonesia has signed the Agreement on the Establishment of the ASEAN Center for Energy, on 22 May 1998;


AND WHEREAS, the Government of the Republic of Indonesia, having examined and considered the aforesaid Agreement, has decided to ratify the same;
