INSTRUMENT OF ACCEPTANCE

The Protocol to Implement the Eighth Package of Commitments on Air Transport Services under the ASEAN Framework Agreement on Services

WHEREAS the Protocol to Implement the Eighth Package of Commitments on Air Transport Services under the ASEAN Framework Agreement on Services was signed by the duly authorized representative of the Government of the Lao People's Democratic Republic, at Pakse, Lao PDR, on 20 December 2013,

WHEREAS paragraph 4 of the Protocol stipulates that this Protocol shall enter into force on the sixtieth day after the deposit of the seventh Instrument of Ratification or Acceptance from ASEAN Member States with the Secretary General of ASEAN, and shall become effective only among the Member States that have ratified or accepted it. For each Member State ratifying or accepting the Protocol after the deposit of the seventh Instrument of Ratification or Acceptance, the Protocol shall enter into force on the sixtieth day after the deposit by such Member State of its Instrument of Ratification or Acceptance,

NOW THEREFORE I, Saleumxay KOMMASITH, Minister of Foreign Affairs, declare that the Government of the Lao People's Democratic Republic, having considered the above-mentioned Protocol, accepts the same and undertakes faithfully to perform and carry out the stipulations therein contained.
