authorized representatives the duly WHEREAS Brunei Dasussalam, Kingdom of Cambodia, the Governments of Republic of Indonesia, the Lao People's Democratic Republic, Malaysia, the Union of Myanmar, the Republic of the Philippines, the Republic of Singapore, the Kingdom of Thailand and the Socialist Republic of Vietnam, have signed the Protocol-4: Technical Requirements Vehicles to the ASEAN Framework Agreement on the Facilitation of Goods in Transit, at Hanoi, Vietnam, on 15 September 1999; and

WHEREAS the Article 8(4) of the Protocol 4 stipulates that the Protocol shall enter into force upon the deposit of Instruments of Ratification or Acceptance by all Contracting Parties with the Secretary - General of ASEAN;

AND WHEREAS the said Protocol was signed by the Minister of Transport of the Government of the Union of Myanmar on 15 September 1999 in Vietnam;

NOW the Government of the Union of Myanmar, having signed and considered the aforesaid Protocol, hereby confirms and ratifies the same and undertakes to perform and carry out all the stipulations contained therein;

In WITNESS WHEREOF, this Instrument of Ratification is signed and sealed by the Minister for Transport of the Union of Myanmar.
