INSTRUMENT OF RATIFICATION

WHEREAS, the duly authorised representatives of the Governments of the Member States of the Association of Southeast Asian Nations have signed the Protocol (1): Designation of Transit Transport Routes and Facilities at Bangkok, Thailand, this Eighth Day of February, in the Year Two Thousand and Seven and its Annex of List of the ASEAN Framework Agreement on the Facilitation of Goods in Transit, in Hanoi, Viet Nam, on the Sixteenth Day of December in the Year Nineteen Ninety Eight.

AND WHEREAS, the Article 2 (2) of the Protocol (1) stipulates that the Protocol shall enter into force upon the deposit of Instrument of Ratification or Acceptance with the Secretary-General of ASEAN with the mutual agreement of the immediate neighbouring Contracting Party or Parties;

NOW THEREFORE, the Government of the Republic of the Union of Myanmar, having considered the Protocol, hereby ratifies the same and undertakes faithfully to perform and carry out all the stipulations contained therein;
