INSTRUMENT OF RATIFICATION

TO WHOM THESE PRESENTS SHALL COME, GREETINGS:

KNOW YE, that whereas, the Association of South East Asian Nations (ASEAN) Framework Agreement on the Facilitation of Cross Border Transport of Passengers by Road Vehicles was signed on 13 October 2017 in Singapore;

WHEREAS, the Framework Agreement aims to simplify and harmonize transport, customs, immigration and quarantine procedures and requirements to facilitate cross border transport of passengers by road vehicles between and among the Contracting Parties;

WHEREAS, the Framework Agreement also allows ASEAN Member States (AMS) to participate in the gains of a robust tourism activity by allowing tourists to visit various scenic spots within the AMS through only one destination or single travel arrangement; and

WHEREAS, the Framework Agreement will likewise promote deeper intra-ASEAN social and cultural interactions and understanding among the AMS;

NOW, THEREFORE, be it known that I, **RODRIGO ROA DUTERTE**, President of the Republic of the Philippines, after having seen and considered the *ASEAN Framework Agreement on the Facilitation of Cross Border Transport of Passengers by Road Vehicles,* do hereby ratify and confirm the same and each and every article and clause thereof.
