## **INSTRUMENT OF RATIFICATION**

## **INSTRUMENT OF RATIFICATION**

**WHEREAS** the Protocol 3 on Domestic Code-Share Rights between Points within the Territory of Any Other ASEAN Member States (“Protocol 3”) under the ASEAN Multilateral Agreement on the Full Liberalisation of Passenger Air Services was signed on behalf of the Government of the Republic of Singapore at Singapore on 13 October 2017;

**AND WHEREAS** Article 4(2) of Protocol 3 provides that Protocol 3 shall be subject to ratification or acceptance by the Contracting Parties;

**AND WHEREAS** Article 4(3) of Protocol 3 provides that Protocol 3 shall enter into force on the date of the deposit of the third Instrument of Ratification or Acceptance from Contracting Parties with the Secretary General of ASEAN;

## **INSTRUMENT OF RATIFICATION**

**WHEREAS** the ASEAN Mutual Recognition Arrangement on Flight Crew Licensing ("Agreement") was signed on behalf of the Government of the Republic of Singapore at Singapore on 13 October 2017;

**AND WHEREAS** Article 12.2 of the Agreement provides that the Agreement shall be subject to ratification or acceptance by the ASEAN Member States in accordance with their respective internal procedures;

**AND WHEREAS** Article 12.3 of the Agreement provides that each ASEAN Member State shall, upon the completion of its internal procedures, deposit the Instruments of Ratification or Acceptance with the Secretary-General of ASEAN, who shall promptly notify all ASEAN Member States of such a deposit;

**AND WHEREAS** Article 12.4 of the Agreement provides that the Agreement shall enter into force on the date of the deposit of the tenth Instrument of Ratification or Acceptance from ASEAN Member States with the Secretary General of ASEAN;

**NOW THEREFORE I**, Dr Vivian Balakrishnan, Minister for Foreign Affairs of the Republic of Singapore, declare that the Government of the Republic of Singapore, having considered the abovementioned Agreement, ratifies the same and undertakes faithfully to perform and carry out the stipulations therein contained.
