Instrument of Ratification

WHEREAS the Protocol 5 on the ASEAN Scheme of Compulsory Motor Vehicle Insurance was done at Kuala Lumpur, Malaysia, on 8 April 2001, by the duly authorized Representatives of the Governments of Brunei Darussalam, the Kingdom of Cambodia, the Republic of Indonesia, Lao People's Democratic Republic, Malaysia, Union of Myanmar, the Republic of the Philippines, the Republic of Singapore, the Kingdom of Thailand, and the Socialist Republic of Vietnam; and

WHEREAS Article 15 paragraph 3 of the aforesaid Protocol provides that this Protocol is subject to ratification or acceptance by the Contracting Parties, and that the Instrument of Ratification or Acceptance shall be deposited with the Secretary-General of ASEAN who shall promptly inform each Contracting Party of such deposit.
