## INSTRUMENT OF RATIFICATION

**WHEREAS** the Government of the Kingdom of Thailand, being an ASEAN Member State, signed the Protocol to Implement the Eighth Package of Commitments on Air Transport Services under the ASEAN Framework Agreement on Services on 20 December 2013; and

**WHEREAS** Paragraph 4 of the aforesaid Protocol stipulates that this Protocol shall enter into force on the sixtieth day after the deposit of the seventh Instrument of Ratification or Acceptance from ASEAN Member States with the Secretary-General of ASEAN, and shall become effective only among the Member States that have ratified or accepted it. For each Member State ratifying or accepting the Protocol after the deposit of the seventh Instrument of Ratification or Acceptance, the Protocol shall enter into force on the sixtieth day after the deposit by such Member State of its Instrument of Ratification or Acceptance;

**THE GOVERNMENT OF THE KINGDOM OF THAILAND**, having considered the aforesaid Protocol, hereby confirms and ratifies the same and undertakes to faithfully perform and carry out all the stipulations contained therein.

**IN WITNESS WHEREOF**, this Instrument of Ratification is signed and sealed by the Minister of Foreign Affairs of the Kingdom of Thailand.

**DONE** at the Ministry of Foreign Affairs, Bangkok, this 27<sup>th</sup> Day of August in the Year Two thousand Five hundred and Fifty-eight of the Buddhist Era, corresponding to the Year Two thousand and Fifteen of the Christian Era.
