**INSTRUMENT OF RATIFICATION  
TO THE PROTOCOL AMENDING THE TREATY  
OF AMITY AND COOPERATION IN SOUTHEAST ASIA**

**WHEREAS** the Protocol Amending The Treaty of Amity and Cooperation in Southeast Asia (hereinafter referred to as the "Protocol") was signed by Brunei Darussalam in Manila on 15th December, 1987;

**AND WHEREAS** the said Protocol amended Articles 14 and 18 of the Treaty of Amity and Cooperation in Southeast Asia;

**AND WHEREAS** Article 3 of the Protocol requires such Protocol to be subject to ratification;

**NOW THEREFORE** the Government of Brunei Darussalam having considered the above-mentioned amendments does hereby **RATIFY** the Protocol and undertakes to carry out faithfully the provisions therein contained.

**IN WITNESS THEREOF** I, Prince Mohamed Bolkiah, Minister of Foreign Affairs of **BRUNEI DARUSSALAM** have signed this Instrument of Ratification and affixed my official Seal.
