INSTRUMENT OF RATIFICATION OF THE THIRD PROTOCOL AMENDING THE TREATY OF AMITY AND COOPERATION IN SOUTHEAST ASIA

WHEREAS the Kingdom of Cambodia together with all High Contracting Parties to the Treaty of Amity and Cooperation in Southeast Asia signed the Third Protocol Amending the Treaty of Amity and Cooperation in Southeast Asia (hereinafter referred to as "the Third Protocol") on 23 July 2010 in Ha Noi, Viet Nam;

WHEREAS Article 3 of the Third Protocol provides that it shall be subject to ratification and shall come into force on the date the last Instrument of Ratification of the High Contracting Parties is deposited;
