INSTRUMENT OF RATIFICATION OF ASEAN AGREEMENT ON CUSTOMS

WHEREAS, the Royal Government of the Kingdom of Cambodia has signed the ASEAN Agreement on Customs on 30 March 2012, in Phnom Penh, Kingdom of Cambodia;

WHEREAS, the article 63 paragraph 1 of the Agreement provides that this Agreement shall enter into force, after all Member States have notified or, where necessary, deposited instruments of ratifications with the Secretary General of ASEAN upon completion of their internal procedures, which shall not take more than 180 days after the signing of this Agreement;

AND WHEREAS, His Majesty the King of Cambodia promulgated the ASEAN Agreement on Customs on 14 June 2014;

NOW THEREFORE, the Royal Government of Cambodia, having considered the aforesaid Agreement, hereby undertakes to faithfully perform and carry out all the stipulations therein contained;

IN WITNESS WHEREOF, I have signed this Instrument of Ratification and affixed hereunto the seal of the Royal Government of Cambodia.
