Instrument of Ratification
of the Protocol 1 on Unlimited Third and Fourth Freedom
Traffic Rights Between Any Points in Contracting Parties

WHEREAS the Government of the Kingdom of Cambodia had signed the Protocol 1 on Unlimited Third and Fourth Freedom Traffic Rights Between Any Points in Contracting Parties (hereinafter referred to as "the Protocol") on 12 November 2010 in Cambodia;

WHEREAS paragraph 2, Article 2 of the Protocol 2 on Fifth Freedom Traffic Rights Between Contracting Parties provides that the Protocol is subject to ratification, and the instrument of ratification shall be deposited with the Secretary-General of ASEAN.

WHEREAS His Majesty the King of Cambodia ratified the Protocol on 09 August 2016,

NOW THEREFORE, the Government of the Kingdom of Cambodia, having considered the Protocol, undertakes faithfully to carry out the stipulations therein contained.
