2. The Protocol to Implement the Eighth Package of Commitments on Air Transport Services under the ASEAN Framework Agreement on Services, signed on 20 December 2013;
3. The Protocol to Implement the Seventh Package of Commitments on Air Transport Services under the ASEAN Framework Agreement on Services, signed on 16 December 2011;
4. The Protocol 2 on Fifth Freedom Traffic Rights Between Contracting Parties, signed on 20 December 2013;
5. The Protocol 1 on Unlimited Third and Fourth Freedom Traffic Rights Between Any Points in Contracting Parties, signed on 12 November 2010.

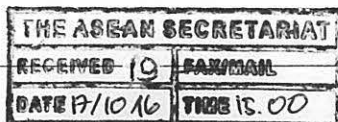

**Instrument of Ratification  
of the Air Transport Agreement Between the Governments of the

WHEREAS the Government of the Kingdom of Cambodia had signed the Air Transport Agreement Between the Governments of the Member States of the Association of Southeast Asian Nations and the Government of the People's Republic of China on 12 November 2010 in Cambodia;

WHEREAS paragraph 2, Article 25 provides that each contracting party shall complete its internal legal procedures necessary for the entry into force of this Agreement.

WHEREAS His Majesty the King of Cambodia ratified the above-mentioned Agreement on 09 August 2016,

NOW THEREFORE, the Government of the Kingdom of Cambodia, having considered the above-mentioned Agreement, undertakes faithfully to carry out the stipulations therein contained.
