## INSTRUMENT OF NOTIFICATION

**WHEREAS**, the Government of the Republic of Indonesia has signed the Agreement on the Establishment of the Regional Secretariat for the Implementation of the ASEAN Mutual Recognition Arrangements on Tourism Professionals, in Jakarta, Indonesia on 30 December 2015;

**AND WHEREAS**, Article 14 paragraph 1 of the said Agreement states "Each ASEAN Member States shall notify the Secretary-General of ASEAN upon completion of its internal legal procedures for entry into force of this agreement. This Agreement shall enter into force on the date of the deposit of the tenth instrument of notification of the fulfilment of such internal legal procedures with the Secretary-General of ASEAN.";

**NOW THEREFORE**, the Government of the Republic of Indonesia hereby notifies the Secretary-General of ASEAN of Indonesia's completion of its internal procedures necessary for entry into force of the said Agreement;

**IN WITNESS WHEREOF**, this Instrument of Notification is signed and sealed by the Minister for Foreign Affairs of the Republic of Indonesia;

## PIAGAM PEMBERITAHUAN


**MENIMBANG**, Pemerintah Republik Indonesia telah menandatangani *Agreement on the Establishment of the Regional Secretariat for the Implementation of the ASEAN Mutual Recognition Arrangements on Tourism Professionals* (Persetujuan tentang Pembentukan Sekretariat Regional untuk Pelaksanaan Pengaturan Saling Pengakuan tentang Tenaga Profesional Pariwisata ASEAN) di Jakarta, Indonesia pada tanggal 30 Desember 2015;

**MENIMBANG PULA**, Pasal 14 ayat (1) Persetujuan dimaksud menyatakan bahwa, "Setiap Negara Anggota ASEAN wajib memberitahukan Sekretaris Jenderal ASEAN setelah penyelesaian prosedur hukum internalnya untuk memberlakukan Persetujuan ini. Persetujuan ini wajib mulai berlaku pada tanggal penyerahan instrumen kesepuluh pemberitahuan pemenuhan prosedur hukum internal kepada Sekretaris Jenderal ASEAN.";

**MAKA DARI ITU**, Pemerintah Republik Indonesia dengan ini memberitahukan kepada Sekretaris Jenderal ASEAN mengenai penyelesaian prosedur internal di Indonesia untuk memberlakukan Persetujuan dimaksud;

**SEBAGAI BUKTI**, Piagam Pemberitahuan ini ditandatangani dan dibubuhi meterai oleh Menteri Luar Negeri Republik Indonesia;

**DIBUAT** di Jakarta pada tanggal *sebelas* bulan *Juli* tahun dua ribu tujuh belas.
