The Ministry of Foreign Affairs of the Republic of Indonesia presents its compliments to all Embassies of the ASEAN Member States, the Embassy of Australia and Embassy of New Zealand in Jakarta and with reference to Article 5 paragraph (2) of the First Protocol to Amend the Agreement Establishing the ASEAN-Australia-New Zealand Free Trade Area, signed on 26 August 2014 in Nay Pyi Taw, Myanmar has the honour to inform the Embassies that the Government of the Republic of Indonesia has completed its internal procedures necessary for the entry into force of the Protocol.

The Ministry in accordance with Article 5 paragraph (3) of the Protocol that stipulates: *"Where a Party does not complete its internal procedures necessary for the entry into force of this Protocol by the entry into force date set out in paragraph 2, this Protocol shall enter into force in relation to that Party on the date of its notification to other Parties of completion of such internal procedures"*, has further the honour to inform all Parties to the Protocol that the Protocol shall enter into force for the Republic of Indonesia on 1 March 2019, the date of this notification.

The Ministry would like to further inform the Parties to the Protocol that the Government of the Republic of Indonesia requires 1 (one) month transitional period starting from the date of entry into force of the Protocol to Indonesia wherein such transitional period, the old and new certificate of origin will be acknowledged by the Government of the Republic of Indonesia.

The Ministry of Foreign Affairs of the Republic of Indonesia avails itself of this opportunity to renew to all Embassies of the ASEAN Member States, the Embassy of Australia, and the Embassy of New Zealand in Jakarta the assurances of its highest consideration.

Kementerian Luar Negeri Republik Indonesia, sesuai dengan ketentuan Pasal 5 ayat (3) yang berbunyi: "*Where a Party does not complete its internal procedures necessary for the entry into force of this Protocol by the entry into force date set out in paragraph 2, this Protocol shall enter into force in relation to that Party on the date of its notification to other Parties of completion of such internal procedures*", dengan hormat memberitahukan kepada seluruh Pihak pada Protokol bahwa Protokol mulai berlaku bagi Republik Indonesia pada tanggal notifikasi ini, yaitu tanggal 1 Maret 2019.
