**INSTRUMENT OF RATIFICATION  
OF THE 2019 FIRST PROTOCOL TO AMEND THE AGREEMENT ON  
COMPREHENSIVE ECONOMIC PARTNERSHIP AMONG JAPAN  
AND THE MEMBER STATES OF THE ASSOCIATION OF SOUTHEAST ASIAN NATIONS**

WHEREAS the Royal Government of Cambodia signed the 2019 First Protocol to Amend the Agreement on Comprehensive Economic Partnership Among Japan and Member States of the Association of Southeast Asian Nations on 24 April 2019 in Ha Noi, Viet Nam;

WHEREAS the Paragraph 1, Article 8 of this Protocol stipulates that the Government of each signatory State shall notify the Governments of other signatory States in writing that its legal procedures necessary for entry into force of this Protocol have been completed. This Protocol shall enter into force on the first day of the second month following the date by which such notifications have been made by the Governments of Japan and at least one (1) ASEAN Member State in relation to those signatory States that have made such notifications by that date;

AND WHEREAS, His Majesty the King of Cambodia promulgated the above-mentioned Protocol on 25 November 2020;

NOW THEREFORE, the Royal Government of Cambodia, having considered the aforesaid Agreement, undertakes to faithfully perform and carry out the stipulations therein contained;

IN WITNESS WHEREOF, I have signed this Instrument of Ratification and affixed hereunto the seal of the Royal Government of Cambodia.
