## INSTRUMENT OF RATIFICATION OF AGREEMENT ON INVESTMENT UNDER THE FRAMEWORK AGREEMENT ON COMPREHENSIVE ECONOMIC COOPERATION BETWEEN THE ASSOCIATION OF SOUTHEAST ASIAN NATIONS AND THE REPUBLIC OF INDIA

WHEREAS the Royal Government of Cambodia signed Agreement on Investment under the Framework Agreement on Comprehensive Economic Cooperation between the Association of Southeast Asian Nations and the Republic of India on 12 November 2014 in Nay Pyi Taw, Myanmar;

WHEREAS the Paragraph 1, Article 30 of this Agreement stipulates that each Party shall notify the other Parties in writing upon completion of its internal requirements necessary for entry into force of this Agreement. This Agreement shall enter into force on 1 July 2015 for any party that has made such notifications provided that India and at least four (4) ASEAN Member States have made such notifications by that date;

AND WHEREAS, His Majesty the King of Cambodia promulgated the abovementioned Protocol on 25 November 2020;

NOW THEREFORE, the Royal Government of Cambodia, having considered the aforesaid Agreement, undertakes to faithfully perform and carry out the stipulations therein contained;

IN WITNESS WHEREOF, I have signed this Instrument of Ratification and affixed hereunto the seal of the Royal Government of Cambodia.
