INSTRUMENT OF ACCEPTANCE

of Protocol 6 on Unlimited Fifth Fourth Freedom Traffic Rights
between ASEAN Capital Cities

WHEREAS Protocol 6 on Unlimited Fifth Fourth Freedom Traffic Rights between ASEAN Capital Cities was signed at Manila, Philippines, on 20th May 2009;

WHEREAS its Article 5 Paragraph 2 stipulates that this Protocol is subject to ratification or acceptance by the Contracting Parties who have ratified or accepted the Agreement. The Instruments of Ratification or Acceptance shall be deposited with the Secretary-General of ASEAN who shall promptly inform each Contracting Party of such deposit;
