INSTRUMENT OF ACCEPTANCE

The Second Protocol to Amend the ASEAN Comprehensive Investment Agreement

WHEREAS The Second Protocol to Amend the ASEAN Comprehensive Investment Agreement was signed by the duly authorized representative of the Government of the Lao People's Democratic Republic, at Hanoi, Vietnam, on 21 September 2017,

AND WHEREAS Article 3, Paragraph 1 stipulates that this Protocol shall form an integral part of the ACIA and shall enter into force after all Member States have notified the completion of their respective internal procedures for the entry into force of this protocol to, or, where necessary, deposited instruments of ratification or acceptance with, the Secretary-General of ASEAN.

NOW THEREFORE I, Saleumxay KOMMASITH, Minister of Foreign Affairs, declare that the Government of the Lao People's Democratic Republic, having considered the said Protocol, accepts the same and undertakes to faithfully perform and carry out the provisions therein contained.

IN WITNESS WHEREOF, I have signed and sealed this Instrument of Acceptance at Vientiane, the Lao People's Democratic Republic, on 31 October 2017.
