## INSTRUMENT OF RATIFICATION

WHEREAS the Protocol 4 on Co- Terminal Rights between Points within the Territory of Any Other ASEAN Member States was signed in Bangkok on 9 November 2018;

AND WHEREAS Article 4 (2) of the Protocol provides that the Protocol shall be subject to ratification or acceptance by the Contracting Parties;

AND WHEREAS Article 4 (3) of the Protocol provides that the Protocol shall enter into force on the date of the deposit of the Third Instrument of Ratification or Acceptance from Contracting parties with the Secretary General of ASEAN;

NOW THEREFORE, I, Aung San Suu Kyi, Union Minister for Foreign Affairs of the Republic of the Union of Myanmar, declare that the Government of the Republic of the Union of Myanmar, having considered the above–mentioned Protocol, ratifies the same and undertakes faithfully to perform and carry out the stipulations therein contained;

IN WITNESS WHEREOF, I have signed this Instrument of Ratification and affixed hereto my seal.
