INSTRUMENT OF NOTIFICATION


WHEREAS the Agreement On Investment Under The Framework Agreement on Comprehensive Economic Cooperation Among the Governments of the Member Countries of the Association of Southeast Asian Nations and the Republic of Korea (hereinafter referred to as "the Agreement") was signed on behalf on the Government of Malaysia on 2 June 2009 in Jeju Island, the Republic of Korea.

AND WHEREAS Article 31 of the Agreement provides that Agreement shall enter into force on the first day of the second month following the latter date on which at least one ASEAN Member State and the Republic of Korea have notified all the other Parties in writing of the completion of their internal procedures;

NOW THEREFORE, the Government of Malaysia, having considered the Agreement, hereby notifies the other Parties that the Government of Malaysia has completed its internal procedures for the entry into force of the Agreement.

IN WITNESS THEREOF, this Instrument of Notification is signed and sealed by the Minister of Foreign Affairs, Malaysia.
