## INSTRUMENT OF RATIFICATION

WHEREAS the Protocol 2 on Fifth Freedom Traffic Rights between Contracting Parties (hereinafter referred to as "the Protocol") of the Air Transport Agreement Between the Governments of the Member States of the Association of Southeast Asian Nations and the Government of the People's Republic of China was signed on the Twentieth Day of December in the year Two thousand and Thirteen:

AND WHEREAS the Protocol was signed on behalf of the Government of the Republic of the Union of Myanmar on the Twentieth Day of December in the year Two thousand and Thirteen;

AND WHEREAS Paragraph 4 of Article 2 of the Protocol provides that it shall enter into force on the date of deposit with the Depository of:

- (a) the written notification from China; and
- (b) the written notifications from at least two ASEAN Member States, whichever date is later;

NOW THEREFORE, I, Wunna Maung Lwin, Union Minister for Foreign Affairs of the Government of the Republic of the Union of Myanmar, do hereby declare that the Government of the Republic of the Union of Myanmar, having considered the Protocol, ratifies the same and undertakes to perform and carry out faithfully all the stipulations therein contained;
