## INSTRUMENT OF NOTIFICATION

WHEREAS, the Protocol (1) on Unlimited Third and Fourth Freedom Traffic Rights between Any Points in Contracting Parties ("the Protocol"), which forms an integral part of the Air Transport Agreement between the Governments of the Member States of the Association of Southeast Asian Nations and the Government of the People's Republic of China (hereinafter referred to as "the Agreement") was signed in Bandar Seri Begawan, Brunei Darussalam, on the Twelfth Day of November, in the Year Two Thousand and Ten;

AND WHEREAS, the Article 3 of the Protocol (1) stipulates that this Protocol shall be deposited and each contracting party shall give written notification to the Depositary;

NOW THEREFORE, the Government of the Republic of the Union of Myanmar, having considered the Protocol, hereby notifies the same and undertakes faithfully to perform and carry out all the stipulations therein contained;
