## INSTRUMENT OF RATIFICATION

## TO WHOM THESE PRESENTS SHALL COME, GREETINGS:

KNOW YE, that whereas, the Protocol to Implement the Second Package of Specific Commitments under the Agreement on Trade in Services of the Framework Agreement on Comprehensive Economic Cooperation between the Association of Southeast Asian Nations (ASEAN) and the People's Republic of China (China) was signed on 16 November 2011 in Bali, Indonesia;

WHEREAS, the *Protocol* serves as the enabling framework to implement commitments pursuant to the ASEAN-China Trade in Services Agreement (TIS Agreement) which under Article 23(2) thereof provides that ASEAN Member States and China shall conclude a second package of specific commitments with the aim of substantially improving on the first package of commitments;

WHEREAS, the Philippine commitments to the *Protocol* apply to 90 sectors/subsectors covering business services, communication services, construction and related engineering services, distribution services, environmental services, financial services, tourism and travel-related services, transport services and energy services; and

**WHEREAS**, the commitments under the Agreement provide predictability in terms of doing business, assuring foreign service suppliers that the current open regime for a particular service sector will not be more restrictive.

NOW, THEREFORE, be it known that I, BENIGNO S. AQUINO III, President of the Philippines, after having seen and considered the Protocol to Implement the Second Package of Specific Commitments under the Agreement on Trade in Services of the Framework Agreement on Comprehensive Economic Cooperation between the Association of Southeast Asian Nations and the People's Republic of China, do hereby ratify and confirm the same and each and every article and clause thereof.
