## INSTRUMENT OF RATIFICATION

## TO WHOM THESE PRESENTS SHALL COME, GREETINGS:

KNOW YE, that whereas, the Third Protocol to Amend the Agreement on Trade in Goods Under the Framework Agreement on Comprehensive Economic Cooperation Among the Governments of the Member Countries of the Association of Southeast Asian Nations and the Republic of Korea was signed on 22 November 2015 in Kuala Lumpur, Malaysia;

WHEREAS, the Protocol recalls the Agreement on Trade in Goods Under the Framework Agreement on Comprehensive Economic Cooperation Among the Governments of the Member Countries of the Association of Southeast Asian Nations and the Republic of Korea; and

**WHEREAS**, the Protocol desires to clarify the scope and conditions under which certain parties may apply reciprocal arrangement in regard to tariff rate treatment as well as provide a line-by-line tariff reduction and/or elimination schedule according to each Party's commitment under the Agreement.

NOW, THEREFORE, be it known that I, BENIGNO S. AQUINO III, President of the Republic of the Philippines, after having seen and considered the Third Protocol to Amend the Agreement on Trade in Goods Under the Framework Agreement on Comprehensive Economic Cooperation Among the Governments of the Member Countries of the Association of Southeast Asian Nations and the Republic of Korea, do hereby ratify and confirm the same and each and every article and clause thereof.
