## INSTRUMENT OF RATIFICATION

WHEREAS Protocol 4 on Co-Terminal Rights between Points within the Territory of Any Other ASEAN Member State under the ASEAN Multilateral Agreement on the Full Liberalisation of Passenger Air Services ("Protocol 4") was signed on behalf of the Government of the Republic of Singapore at Bangkok, Thailand, on 9 November 2018;

**AND WHEREAS** Article 4(2) of Protocol 4 provides that Protocol 4 shall be subject to ratification or acceptance by the Contracting Parties;

AND WHEREAS Article 4(3) of Protocol 4 provides that Protocol 4 shall enter into force on the date of the deposit of the third Instrument of Ratification or Acceptance from Contracting Parties with the Secretary General of ASEAN;

NOW THEREFORE I, Dr Vivivan Balakrishnan, Minister for Foreign Affairs of the Republic of Singapore, declare that the Government of the Republic of Singapore, having considered the abovementioned Protocol 4, ratifies the same and undertakes faithfully to perform and carry out the stipulations therein contained.

IN WITNESS WHEREOF, I have signed this instrument of ratification on behalf of the Republic of Singapore.
