## INSTRUMENT OF RATIFICATION

**WHEREAS** the Second Protocol to Amend the ASEAN Comprehensive Investment Agreement was signed at Ha Noi, the Socialist Republic of Viet Nam, on 21 September 2017, by the duly authorised Representative of the Government of the Kingdom of Thailand;


**WHEREAS** Article 3, paragraph 1 of the Protocol stipulates that this Protocol shall enter into force after all Member States have notified the completion of their respective internal procedures for the entry into force of this Protocol to, or, where necessary, deposited instruments of ratification or acceptance with, the Secretary-General of ASEAN; and

**WHEREAS** Article 3, paragraph 2 of the Protocol stipulates that the Secretary-General of ASEAN shall promptly notify all Member States of the notifications or deposit of each instrument of ratification or acceptance;

**THE GOVERNMENT OF THE KINGDOM OF THAILAND**, having considered the aforesaid Protocol, hereby confirms and ratifies the same and undertakes to faithfully perform and carry out all the stipulations contained therein.

**IN WITNESS WHEREOF**, this Instrument of Ratification is signed and sealed by the Minister of Foreign Affairs of the Kingdom of Thailand.

**DONE** at the Ministry of Foreign Affairs, Bangkok, this 5<sup>th</sup> Day of April in the Year Two thousand Five hundred and Sixty-two of the Buddhist Era, corresponding to the Year Two thousand and Nineteen of the Christian Era.
