INSTRUMENT OF RATIFICATION


WHEREAS the Agreement on the ASEAN Harmonized Electrical and Electronic Equipment (EEE) Regulatory Regime was signed at Kuala Lumpur, Malaysia on 9 December 2005 by duly authorized Representatives of the Governments of Brunei Darussalam, the Kingdom of Cambodia, the Republic of Indonesia, the Lao People's Democratic Republic, Malaysia, the Union of Myanmar, the Republic of the Philippines, the Republic of Singapore, the Kingdom of Thailand and the Socialist Republic of Viet Nam; and

WHEREAS Article 13 paragraph 1 of the aforesaid Agreement stipulates that the Agreement shall enter into force on the deposit of the instruments of ratification or acceptance by all signatory Governments with the Secretary General of ASEAN;

THE GOVERNMENT OF THE KINGDOM OF THAILAND, having considered the aforesaid Agreement, hereby confirms and ratifies the same and undertakes to faithfully perform and carry out all the stipulations contained therein.

IN WITNESS WHEREOF, this Instrument of Ratification is signed and sealed by the Minister of Foreign Affairs of the Kingdom of Thailand.

DONE at the Ministry of Foreign Affairs, Bangkok, this 17th Day of September in the Year Two thousand Five hundred and Fifty-five of the Buddhist Era, corresponding to the Year Two thousand and Twelve of the Christian Era.
