## INSTRUMENT OF RATIFICATION

**WHEREAS** the Protocol to Amend the ASEAN Comprehensive Investment Agreement was signed by the duly authorised Representatives of the Government of the Kingdom of Thailand on 26 August 2014;

**WHEREAS** Article 6, paragraph 1 of the aforesaid Protocol stipulates that the Protocol shall enter into force after all Member States have notified the completion of their internal procedures for the entry into force of this Protocol to, or, where necessary, deposited instruments of ratification or acceptance with, the Secretary-General of ASEAN; and

**WHEREAS** Article 6, paragraph 3 of the aforesaid Protocol stipulates that the Protocol shall be deposited with the Secretary-General of ASEAN, who shall promptly furnish a certified copy thereof to each Member State;

**THE GOVERNMENT OF THE KINGDOM OF THAILAND**, having considered the aforesaid Protocol, hereby confirms and ratifies the same and undertakes to faithfully perform and carry out all the stipulations contained therein.

**IN WITNESS WHEREOF**, this Instrument of Ratification is signed and sealed by Permanent Secretary, Acting for the Minister of Foreign Affairs of the Kingdom of Thailand.

**DONE** at the Ministry of Foreign Affairs, Bangkok, this 22<sup>nd</sup> Day of August in the Year Two thousand Five hundred and Fifty-seven of the Buddhist Era, corresponding to the Year Two thousand and Fourteen of the Christian Era.
