INSTRUMENT OF RATIFICATION


WHEREAS the ASEAN Comprehensive Investment Agreement was signed at Cha-am, Thailand on 26 February 2009, by the duly authorised Representatives of Brunei Darussalam, the Kingdom of Cambodia, the Republic of Indonesia, the Lao People's Democratic Republic, Malaysia, the Union of Myanmar, the Republic of the Philippines, the Republic of Singapore, the Kingdom of Thailand and the Socialist Republic of Viet Nam;

WHEREAS Article 48 of the Agreement stipulates that this Agreement shall enter into force after all Member States have notified or, where necessary, deposited instruments of ratification with the Secretary-General of ASEAN who shall promptly notify all Member States of the notification or deposit of each instrument of ratification;

THE GOVERNMENT OF THE KINGDOM OF THAILAND, having considered the aforesaid Agreement, hereby confirms and ratifies the same and undertakes to faithfully perform and carry out all the stipulations contained therein.

IN WITNESS WHEREOF, this Instrument of Ratification is signed and sealed by the Minister of Foreign Affairs of the Kingdom of Thailand.

DONE at the Ministry of Foreign Affairs, Bangkok, this 7th Day of December in the Year Two thousand Five hundred and Fifty-four of the Buddhist Era, corresponding to the Year Two thousand and Eleven of the Christian Era.
