INSTRUMENT OF RATIFICATION FOR THE
AGREEMENT ON INVESTMENT AMONG THE GOVERNMENTS OF
THE HONG KONG SPECIAL ADMINISTRATIVE REGION OF THE
PEOPLE'S REPUBLIC OF CHINA AND THE MEMBER STATES OF
THE ASSOCIATION OF SOUTHEAST ASIAN NATIONS

WHEREAS the Agreement on Investment Among the Governments of the Hong Kong Special Administrative Region of the People's Republic of China and the Member States of the Association of Southeast Asian Nations (hereinafter referred to as "the Agreement") was signed on behalf of the Government of Brunei Darussalam at Ha Noi, the Socialist Republic of Viet Nam on 18th May, 2018;

WHEREAS Article 26 of the Agreement provides that the Agreement shall be subject to ratification, acceptance or approval and that the instrument of ratification, acceptance or approval by a Party shall be deposited with the Secretary-General of ASEAN;

NOW THEREFORE I, SULTAN HAJI HASSANAL BOLKIAH, Sultan and Yang Di-Pertuan of Brunei Darussalam, declare that the Government of Brunei Darussalam, having considered the Agreement, hereby ratifies the same and undertakes faithfully to carry out the stipulations therein contained;
