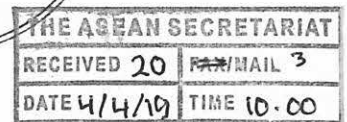

INSTRUMENT OF RATIFICATION

WHEREAS the Agreement on Investment among the Governments of the Hong Kong Special Administrative Region of the People's Republic of China and the Member States of the Association of Southeast Asian Nations was signed in Ha Noi, Viet Nam on 18 May 2018;

AND WHEREAS Paragraph 1 of the Article 26 of the Agreement specifies that the Agreement shall be subject to ratification, acceptance or approval; the instrument of ratification, acceptance or approval by a Party shall be deposited with the depositary who shall promptly notify all other Parties of each deposit; and this Agreement shall enter into force on 1 January 2019 for the Parties that have deposited their instruments of ratification, acceptance or approval provided that the Hong Kong Special Administrative Region and at least four ASEAN Member States have deposited their instruments of ratification, acceptance or approval;

AND WHEREAS Paragraph 2 of the Article 26 of the Agreement states clearly that if this Agreement does not enter into force on the date referred to in paragraph 1, it shall enter into force, for the Parties that have deposited their instruments of ratification, acceptance or approval, 60 days after the date by which the Hong Kong Special Administrative Region and at least four ASEAN Member States have deposited their instruments of ratification, acceptance or approval;

NOW THEREFORE, I, Aung San Suu Kyi, Union Minister for Foreign Affairs of the Republic of the Union of Myanmar, declare that the Government of the Republic of the Union of Myanmar, having considered the above-mentioned Agreement, ratifies the same and undertakes faithfully to perform and carry out the stipulations therein contained;

IN WITNESS THEREOF, I have signed this Instrument of Ratification and affixed hereto my seal.
