## INSTRUMENT OF RATIFICATION

**WHEREAS** the Agreement on Investment Among the Governments of the Hong Kong Special Administrative Region of the People's Republic of China and the Member States of the Association of Southeast Asian Nations ("Agreement") was signed on behalf of the Government of the Republic of Singapore at Manila, Philippines, on 12 November 2017;

**AND WHEREAS** Paragraphs 1 and 2 of Article 26 of the Agreement provide that the Agreement shall enter into force on 1 January 2019 for the Parties that have deposited their instruments of ratification, acceptance or approval provided that Hong Kong, China and at least four ASEAN Member States have deposited their instruments of ratification, acceptance or approval, or 60 days after the date by which Hong Kong, China and at least four ASEAN Member States have deposited their instruments of ratification, acceptance or approval;

**NOW THEREFORE I**, Dr Vivian Balakrishnan, Minister for Foreign Affairs of the Republic of Singapore, declare that the Government of the Republic of Singapore, having considered the abovementioned Agreement, ratifies the same and undertakes faithfully to perform and carry out the stipulations therein contained.
