INSTRUMENT OF RATIFICATION

WHEREAS the Agreement on Investment among the Governments of the Hong Kong Special Administrative Region of the People's Republic of China and the Member States of the Association of Southeast Asian Nations was signed at Manila, the Republic of the Philippines, on 12 November 2017 by the duly authorized Representative of the Government of the Kingdom of Thailand;


WHEREAS Article 26, paragraph 1 of the Agreement stipulates that the Agreement shall be subject to ratification, acceptance or approval; the instrument of ratification, acceptance or approval by a Party shall be deposited with the Secretary-General of ASEAN who shall promptly notify all other Parties of each deposit; and this Agreement shall enter into force on 1 January 2019 for the Parties that have deposited their instruments of ratification, acceptance or approval provided that the Hong Kong Special Administrative Region and at least four ASEAN Member States have deposited their instruments of ratification, acceptance or approval; and

WHEREAS Article 26, paragraph 2 of the Agreement stipulates that if this Agreement does not enter into force on the date referred to in paragraph 1, it shall enter into force, for the Parties that have deposited their instruments of ratification, acceptance or approval, 60 days after the date by which the Hong Kong Special Administrative Region and at least four ASEAN Member States have deposited their instruments of ratification, acceptance or approval;

THE GOVERNMENT OF THE KINGDOM OF THAILAND, having considered the aforesaid Agreement, hereby confirms and ratifies the same and undertakes to faithfully perform and carry out all the stipulations contained therein.

IN WITNESS WHEREOF, this Instrument of Ratification is signed and sealed by the Minister of Foreign Affairs of the Kingdom of Thailand.

DONE at the Ministry of Foreign Affairs, Bangkok, this 28th Day of December in the Year Two thousand Five hundred and Sixty-one of the Buddhist Era, corresponding to the Year Two thousand and Eighteen of the Christian Era.
