Excellency,

I, instructed by the Government, have the honor to deposit the Instrument of Ratification of the People's Republic of China (hereinafter referred to as "the PRC") for the Agreement Establishing ASEAN+3 Macroeconomic Research Office (hereinafter referred to as "the Agreement") signed by the representative from the Government of the PRC in Washington on 10 October 2014, and, on behalf of the Government of the PRC, to state the following:

1. In accordance with the Basic Law of the Hong Kong Special Administrative Region of the PRC, the Hong Kong Special Administrative Region (hereinafter referred to as "the HKSAR"), under authorizations from the Central People's Government of the PRC, using the name "Hong Kong, China", signed the Agreement. The Government of the PRC will assume the responsibility for the international rights and

obligations arising from the implementation of the privileges and immunities provisions of the Agreement in the HKSAR.

2. In accordance with the Basic Law of the Macao Special Administrative Region of the PRC, the Government of the PRC decides that the Agreement applies to the Macao Special Administrative Region of the PRC.

The HKSAR Government will deposit the legal instrument for the entry into force the Agreement in the HKSAR on its own.

It would be appreciated if the contents of this Note could be placed formally on record and brought to the attention of all the other Parties to the Agreement.


