INSTRUMENT OF RATIFICATION

WHEREAS the Agreement Establishing ASEAN+3 Macroeconomic Research Office ("AMRO") was done in Washington on the tenth day of October in the year two thousand and fourteen;

WHEREAS it is provided in Article 24 of the Agreement that the Secretary-General of the Association of Southeast Asian Nations shall be the depositary of the Agreement;

AND WHEREAS the Government of the Republic of Korea has considered the said Agreement and all the constitutional requirements of the Republic of Korea for the ratification of the said Agreement have been met;

NOW THEREFORE, I hereby declare, on behalf of the Government of the Republic of Korea, that the Government of the Republic of Korea has ratified the said Agreement, which shall enter into force for the Republic of Korea in accordance with Article 25 thereof.

IN WITNESS WHEREOF, I, Yun Byung-se, Minister of Foreign Affairs of the Republic of Korea, have signed this Instrument of Ratification and caused the Seal of the Minister of Foreign Affairs of the Republic of Korea to be hereunto affixed.

Done at Seoul this seventh day of December in the year of two thousand and fifteen.
