Instrument of Ratification

WHEREAS, the Regional Comprehensive Economic Partnership (RCEP) Agreement was signed by the RCEP Ministers from the member states of the Association of Southeast Asian Nations, Australia, China, Japan, Korea and New Zealand at the Virtual Signing Ceremony as the sidelines of the 4th RCEP Summit witness by the Leaders.

AND WHEREAS, Article 20.6 of the RCEP Agreement stipulates that the agreement shall enter into force for those signatory States that have deposited their instrument of ratification, acceptance, or approval, 60 days after the date on which at least signatory States which are Member States of ASEAN and three signatory States other than Member States of ASEAN have deposited their instrument of ratification, acceptance, or approval with the Depositary. After the date of entry into force of the Agreement, the Agreement shall enter into force for any other signatory State 60 days after the date on which it has deposited its instrument of ratification, acceptance, or approval with the Depositary.

NOW THEREFORE, I, Wunna Maung Lwin, Union Minister for Foreign Affairs of the Republic of the Union of Myanmar, declare that the Republic of the Union of Myanmar, having considered the aforesaid Agreement, ratifies the same and undertakes to faithfully to perform and carry out all the stipulations contained therein.
