## INSTRUMENT OF RATIFICATION

WHEREAS the Protocol 3 on the Expansion of Fifth Freedom Traffic Rights between Contracting Parties of the Air Transport Agreement between the Governments of the Member States of the Association of Southeast Asian Nations and the Government of the People's Republic of China ("the Protocol") was signed on 15 November 2019 in Hanoi, Viet Nam;

WHEREAS paragraph 2 of Article 2 of the Protocol provides that Each Contracting Party shall complete its relevant internal legal procedures necessary for the entry into force of this Protocol and shall, after the completion of its internal legal procedures, deposit instrument of ratification, approval or acceptance with or give written notification to the Depositary, who shall promptly inform each Contracting Party of such deposit or notification.

AND WHEREAS paragraph 3 of Article 2 of the Protocol provides that this Protocol shall enter into force on the date of the deposit with or notification to the Depository pursuant to paragraph 2 from:

- (a) China; and
- (b) at least two ASEAN Member States

and shall enter into force only among the Contracting Parties that have deposited instrument of ratification, approval, or acceptance with or given their written notifications to the Depositary;

NOW THEREFORE, I, Wunna Maung Lwin, Union Minister for Foreign Affairs of the Republic of the Union of Myanmar, do hereby declare that the Government of the Republic of the Union of Myanmar, having considered the abovementioned Protocol, ratifies the same and undertakes to perform and carry out faithfully all the stipulations therein contained.
