



MEMORANDUM OF UNDERSTANDING ON ASEAN CO-OPERATION IN AGRICULTURE AND FOREST PRODUCTS PROMOTION SCHEME

The Governments of Brunei Darussalam, the Kingdom of Cambodia, the Republic of Indonesia, the Lao People's Democratic Republic, Malaysia, the Republic of the Union of Myanmar, the Republic of the Philippines, the Republic of Singapore, the Kingdom of Thailand and the Socialist Republic of Viet Nam being members of the Association of Southeast Asian Nations (ASEAN) (hereinafter collectively referred to as "Member States" or individually as "Member State");

REITERATING our resolve as stated in the ASEAN Economic Community Blueprint 2025, adopted by the Twenty-seventh ASEAN Summit on 22 November 2015, in particular to enhance trade facilitation, involvement of agricultural producers in the integration process, and the competitiveness of food, agriculture, forest products or commodities;

REITERATING our commitment to the Vision and Strategic Plan for ASEAN Cooperation in Food, Agriculture and Forestry (FAF) 2025, which provides the focus of cooperation in the areas of enhancing quantity and quality of production, enhancing economic integration and market access, ensuring food security and safety, assisting small producers and SMEs to meet global market standards, strengthening joint approaches on international and regional issues affecting the FAF sector, and promoting sustainable forest management;

CONSIDERING that agriculture and forestry will remain as important aspects of the ASEAN economy with particular significant impact on income enhancement and poverty alleviation and that human resources can be

developed through the transfer of technology, a result of the implementation of bold investment programmes;

REAFFIRMING our awareness of the dynamics of recent global affairs, the trend towards regional trade and economic integration, and environmental issues;

RECOGNISING the need to realign the food, agriculture, and forestry sectors within the mainstream of ASEAN economic integration and that these sectors cannot progress without promoting trade and ASEAN must take full advantage of the relevant international organisations and fora;

RECOGNISING the importance of liberalising the agriculture and forestry sectors and transforming these sectors from production-push approach to market-oriented approach;

REALISING the importance of agriculture and forest products diversification, intensification of downstream processing and higher value added activities; and

DESIRING to improve the Memorandum of Understanding on ASEAN Cooperation in Agriculture and Forest Products Promotion Scheme, signed in Nay Pyi Taw on 24 September 2014 (hereinafter referred to as “the 2014 Memorandum of Understanding”) which is set to expire on 23 September 2019 and the need to further strengthen cooperation among Member States on promotion of agriculture and forest products;

HAVE REACHED THE FOLLOWING UNDERSTANDINGS:

ARTICLE 1 DEFINITIONS

For the purposes of the established ASEAN Co-operation on Agriculture and Forest Products Promotion Scheme (hereinafter referred to as the "Scheme"),

- a. **"promotion"** means joint efforts to improve the competitiveness of ASEAN Agriculture and Forest Products (hereinafter referred to as "Products" in the plural form and "Product" in the singular form); and
- b. **"joint efforts"** include negotiation, collective bargaining, and addressing issues and problems encountered by Member States in international markets.

ARTICLE 2 OBJECTIVES

1. The objectives of the Scheme are to:
 - (a) strengthen the collective bargaining position of ASEAN on matters affecting trade in the Products in international markets;
 - (b) expand the Products exported to international markets through product diversification, intensification of downstream processing and higher value-added activities;
 - (c) strengthen cooperation, support and facilitate trade promotion for organic products and friendly environmental products;
 - (d) continue upgrading the quality of the Products and food safety;

- (e) lay down the foundation for greater and closer economic ties between Member States; and
- (f) Is ensure that ASEAN Products are produced through sustainable manners

ARTICLE 3 PRODUCTS COVERED BY THE SCHEME

1. The Products to be covered by the Scheme are listed in **Annex A**, which may be reviewed by the Joint Committee as referred to in Article 11 (Coordinating Mechanism).
2. A Product to be considered for inclusion in the Scheme must satisfy any two (2) of the following criteria:
 - (a) the Product is being subjected to discriminatory treatment or non-trade related issues or both;
 - (b) the Product is of major export interest to or has export potential, for at least two Member States; or
 - (c) the Product has economic impact, in terms of income generation and employment, on a large number of people in the Member States.
3. The application for the inclusion or removal of a Product under the Scheme shall be considered and decided within three (3) months upon receipt of the application at a meeting of the Joint Committee or by *ad referendum*.

**ARTICLE 4
RELATION TO OTHER AGREEMENT**

This Memorandum of Understanding will not derogate existing rights and obligation under existing international agreements to which Member States are Parties.

**ARTICLE 5
PRODUCT PROMOTION IN INTERNATIONAL
MARKETS**

1. Promotional programmes of the Products will be initiated by the private sector in consultation and co-operation with the National Coordinator of Member States as referred to in Article 10 (Designated Authority).
2. Member States will endeavour to assist and facilitate private sectors' initiatives.
3. The Scheme provides guidelines and procedures for joint promotions for the Products which include the following programmes or activities:
 - (a) joint efforts to counter discriminatory campaign against the Products;
 - (b) joint efforts to overcome discriminatory tariff or non-tariff barriers and unfair trade practices imposed by an importing country or countries; and
 - (c) joint promotion of the Products through participation in promotional activities.
4. The joint promotion of a Product will be carried out and decided upon by a Lead Country whose selection will be made on the basis of the expertise possessed by that country. The Lead Country for a Product may withdraw

from its position as Lead Country by notifying its intention to the Joint Committee at least three (3) months before the Joint Committee Meeting. The Joint Committee will consider and decide on the replacement.

5. The Lead Country needs to implement the most appropriate strategy to promote the Product being assigned. The Lead Country is responsible to examine and recommend measures for joint efforts and approaches to address issues or concerns affecting trade of the Product being assigned.

6. The Scheme will avoid duplication of promotional activities currently being carried out by other regional and international organisations to which Member States are members.

ARTICLE 6 JOINT ASEAN POSITION AT INTERNATIONAL FORA

Member States will endeavour to hold consultations and co-operation among themselves to formulate a joint ASEAN position at international fora on issues relating to the Products.

ARTICLE 7 ENHANCEMENT OF INTRA-ASEAN TRADE

Member States will endeavour to enhance intra-ASEAN trade which includes the following areas:

- (a) consultations and exchange of experiences and information on trade and investment policies and strategies;
- (b) co-operation on border and non-border measures to supplement and complement

efforts towards liberalising trade and investment to include reciprocal recognition of tests and certification, removal of barriers, and fair competition;

- (c) co-operative efforts in downstream and value-added activities; and
- (d) coordination and cooperation in reducing trade-barriers between Member States.

ARTICLE 8 ENHANCEMENT OF COMPETITIVENESS OF THE PRODUCTS

Member States endeavour to carry out strategic actions towards enhancing the long term competitive position of the Products through the following efforts:

- (a) strengthening co-operation in human resources development;
- (b) enhancing complementarity of the Products;
- (c) intensifying co-operation in technology development and transfer;
- (d) accelerating the harmonisation of standards, consistent with international standards; and
- (e) strengthening co-operation in the implementation of sanitary and phytosanitary measures to promote trade competitiveness of Member States.

**ARTICLE 9
PROTECTION OF INTELLECTUAL PROPERTY
RIGHTS**

1. The protection of intellectual property rights will be enforced in conformity with the respective national laws, rules, and regulations of the Member States and with other international agreements to which Member States are parties.

2. The use of the name, logo and/or official emblem of any of the Member States on any publication, document and/or paper is prohibited without the prior written approval of the Member States”.

3. Notwithstanding paragraph 1, the intellectual property rights in respect of any technological development, and any products and services development, carried out under the Scheme:

- (a) jointly by the Member States or research results obtained through the joint activity effort of the Member States, shall be jointly owned by the Member States in accordance with the terms to be mutually agreed upon; and
- (b) solely and separately by the Member States or the research results obtained through the sole and separate effort of the Member States, will be solely owned by the Member States concerned.

**ARTICLE 10
DESIGNATED AUTHORITY**

The list of National Coordinators and Focal Points for the implementation of this Memorandum of Understanding on

behalf of the Government of the Member States is attached in **Annex B**.

ARTICLE 11 COORDINATING MECHANISM

1. The Joint Committee established under the 2014 Memorandum of Understanding is entrusted to oversee the implementation of the Scheme under this Memorandum of Understanding. The Joint Committee is chaired on a rotational basis in alphabetical order of the names of the Member States. The Chairperson assumes chairmanship of the Joint Committee at the start of the Joint Committee Meeting until the start of the next Joint Committee Meeting. The organisational structure of the Joint Committee appears in **Annex C**.

2. The Joint Committee, comprising of the Chairperson of the National Focal Points Working Groups or Industry Clubs, relevant government officials, the representative of the ASEAN Chambers of Commerce and Industry (ASEAN-CCI), representative of relevant private sector recommended by the National Coordinators and Focal Point, and the ASEAN Secretariat, as the secretary of the Joint Committee.

3. The National Coordinators are responsible for coordinating activities of the Lead Countries and Focal Points.

4. Member States identified to lead a particular Product as listed in **Annex A** will endeavour to establish the meeting of the Working Group, organise and call for the meeting at least once a year, as deemed appropriate. The Lead Country will chair the meeting of the Working Group called "The Meeting of the National Focal Points Working Group on [subject matter] of the Promotion Scheme" (Working Group).

5. The Working Groups or Industry Clubs established by private sectors including the ASEAN Vegetable Oils Club (AVOC) and the ASEAN Forest Products Industry Club (AFPIC) may continue with their establishment and report their activities to the Joint Committee.

6. The Chairperson of the Working Groups or Industry Clubs will present the progress report of its activity for the consideration of the Joint Committee Meeting.

7. The Joint Committee may establish its own rules of procedures.

ARTICLE 12 FINANCIAL ARRANGEMENTS

1. The financial arrangements to cover expenses for the co-operative activities undertaken pursuant to this Memorandum of Understanding will be agreed upon by the respective participating Member States on a case-by-case basis, subject to the availability of funds.

2. Notwithstanding paragraph 1, expenses for organising the meetings of the Joint Committee or Working Groups will be covered by the Member State hosting the meetings. The Member State, which is sending its representatives for participation in the meetings of the Working Groups, is responsible for their own travel, participation expenses and accommodation. Any Member State may sponsor other Member States to participate in any Working Group meeting.

ARTICLE 13 CONFIDENTIALITY

1. Member States will endeavour to observe the confidentiality and secrecy of the documents, information and other data received from or supplied to the other Member States pursuant to this Memorandum of Understanding. No Member States will be permitted to disclose or distribute the contents, confidential documents, information or data related to this Memorandum of Understanding to any third party by any means without prior written consent of the Member States that furnished them, except in the following circumstances:

- (a) to their respective Governments and regulatory authorities; and
- (b) on a need-to-know basis and subject to such Member States agreeing to undertake confidentiality arrangements as may be appropriate, in order to satisfy the objectives of this Memorandum of Understanding.

2. The provisions of this Article 13 (Confidentiality) will continue to be binding between Member States notwithstanding the expiration or termination of this Memorandum of Understanding.

ARTICLE 14 SUSPENSION

Each Member State reserves the right for reasons of national security, national interest, public order or public health to suspend temporarily, either in whole or in part, the implementation of this Memorandum of Understanding which suspension shall take effect immediately after notification has been given to other

Member States through diplomatic channels and/or Designated Authority as referred to in Article 10 (Designated Authority).

ARTICLE 15 DISPUTE SETTLEMENT

Any difference or dispute between any Member States concerning the interpretation, application or implementation of any provisions of this Memorandum of Understanding will be settled amicably by Member States through negotiations and consultations.

ARTICLE 16 DEPOSITORY

This Memorandum of Understanding will be deposited with the Secretary-General of ASEAN who shall promptly furnish a certified copy thereof to each Member States.

ARTICLE 17 FINAL PROVISIONS

1. This Memorandum of Understanding becomes effective on the date of its signature and will continue to have effect for a period of five (5) years. It may be extended beyond the original five-year period by the consensus of all Member States.

2. Upon coming into effect, this Memorandum of Understanding will supersede the 2014 Memorandum of Understanding. All programmes and activities under the 2014 Memorandum of Understanding will remain valid until the completion of the said programmes and activities, unless agreed otherwise by the Member States.

3. Any Member State may request in writing, a revision, modification or amendment of all or any part of this Memorandum of Understanding.

4. Any revision, modification or amendment agreed to by the Member States will be reduced into writing and will form part of this Memorandum of Understanding.

5. Such revision, modification or amendment shall come into effect on such date that may be determined by the Member States.

6. Notwithstanding paragraphs 3 and 4, any Annex to this Memorandum of Understanding may be revised, modified or amended subject to the endorsement by the Senior Officials Meeting of the ASEAN Ministers on Agriculture and Forestry (SOM-AMAF).

7. Any revision, modification or amendment to this Memorandum of Understanding will not affect any ongoing activities made pursuant to this Memorandum of Understanding and will remain valid and effective until the completion of such agreed activities, unless agreed otherwise by the Member States

IN WITNESS WHEREOF, the undersigned being duly authorised thereto by their respective Governments, have signed this Memorandum of Understanding.
