INSTRUMENT OF RATIFICATION
OF THE SECOND PROTOCOL TO AMEND THE AGREEMENT
ESTABLISHING THE ASEAN-AUSTRALIA-NEW ZEALAND FREE TRADE AREA

WHEREAS the Government of the Kingdom of Cambodia signed the Second Protocol to amend the Agreement Establishing the ASEAN-Australia-New Zealand Free Trade Area (hereinafter referred to as "the Protocol") on 14 February 2024, in Semarang, the Republic of Indonesia;

WHEREAS Paragraph 2 of Article 2 of the Protocol stipulates that this Protocol shall enter into force 60 days after the date on which Australia, New Zealand and at least four ASEAN Member States have deposited their Instruments of Ratification, Acceptance or Approval;

AND WHEREAS, His Majesty the King of Cambodia promulgated the above-mentioned Protocol on 8 November 2025;

NOW THEREFORE, the Government of the Kingdom of Cambodia, having considered the aforesaid Protocol, ratifies this Protocol and undertakes faithfully to perform and carry out the stipulations therein contained;

IN WITNESS WHEREOF, I have signed this Instrument of Ratification and affixed hereunto the seal of the Government of the Kingdom of Cambodia.
