INSTRUMENT OF ACCEPTANCE

WHEREAS the Agreement Establishing the ASEAN Promotion Centre on Trade, Investment and Tourism among the Member Countries of the Association of Southeast Asian Nations and Japan was done at Tokyo on 22 December 1980;

WHEREAS the Second Amendment to the Agreement Establishing the ASEAN Promotion Centre on Trade, Investment and Tourism was adopted on 20 June 2024 by the Council of the ASEAN-Japan Centre; and

WHEREAS Article XXI, paragraph 3 of the Agreement, stipulates that acceptance by the Members of amendments to this Agreement shall be effected by the deposit of instruments of acceptance with the Depository Authorities;
