WHEREAS, in the 46th Summit, the Association of Southeast Asian Nations (ASEAN) Member States have agreed to accept Timor-Leste as a member of ASEAN at the 47th Summit to be held on 26-28 October 2025;


WHEREAS, the ASEAN Member States have agreed upon the Accession of Timor-Leste to the Treaty of Southeast Asia Nuclear Weapon Free Zone (SEANWFZ);

AND WHEREAS, the Accession of Timor-Leste requires amendment of the Treaty of the Southeast Asia Nuclear Weapon Free Zone (SEANWFZ);

NOW THEREFORE I, BE IT KNOWN, that the Government of the Republic of Indonesia hereby accepts the Amendment and undertakes to perform and carry out the stipulations contained therein;

IN WITNESS WHEREOF, this Instrument of Acceptance is signed and sealed by the Minister for Foreign Affairs of the Republic of Indonesia;

DONE at Jakarta on this ^{twenty second} day of ^{September} in the year two thousand and twenty five.
